Conditions that block the drainage or free flow of rainwater or snow or ice melt, or allow ponding or standing water, or allow uncontrolled drainage onto any part of the roof system. F. Contact with green, treated or wet lumber, corrosive ged iron, inadequate vapor barriers or lack of adequate ventilation of attic spaces. G.
